

This Agreement ("Agreement") is made and entered into by and between Little Big Empire ("LBE"), and the undersigned party ("Creator"), collectively referred to as the "Parties."

1. Grant of Rights

1.1 The Creator hereby grants LBE exclusive rights to manage and distribute any project submitted to LBE. Projects include, but are not limited to, albums, singles, and instrumentals.

1.2 The Creator retains ownership of the project and may use or sell the project, provided it does not conflict with the terms of this Agreement. Any sale of the project must be approved by LBE.

1.3 LBE is granted the right to use the project for all marketing and advertising purposes. However, LBE shall not profit from the project unless expressly approved or negotiated with the Creator.

2. Revenue Distribution

2.1 For any project submitted, revenue will be distributed as follows:

- 10% to LBE for project management and distribution.
- 45% to the Creator.
- 45% to any other parties involved (e.g., featured artists, producers).

3. Project Release and Management

3.1 All projects will be released on LBE's platform. Any artist and/or producer included in the project will be credited as featured.

3.2 LBE will track data for project management purposes. Marketing and advertising materials created by LBE will be made available to all parties involved upon request.

4. Project Submission and Collaboration

4.1 Projects can be submitted to LBE at any time.

4.2 To submit a project, the Creator must send an email to director@thelittlebigempire.com with the following details:

- Project title
- List of all contributors (artists, producers, etc.)
- Description of the project (e.g., genre, theme)
- Any relevant files (audio files, artwork, etc.)
- Any specific instructions or requests
- Copies of any pre-existing agreements with other involved parties

4.3 If the Creator has existing agreements with other involved parties, all such agreements must be submitted and confirmed by LBE before the project is accepted.

4.4 LBE may match artists, producers, and beats for collaboration. Notification of such usage will be provided to all involved parties.

4.5 If any party does not approve of the use of their work, they have 7 days from the date of notification to appeal with appropriate reasoning to request removal of the project or any associated .
marketing

4.6 If the Creator posts or makes any content related to the project, they must give credit to LBE in the content and/or description using [@littlebigempire](#), thelittlebigempire.com, or their custom LBE affiliate link.

5. Term and Termination

5.1 This Agreement shall commence upon the date of signature and continue until terminated by either party with a 30-day written notice.

5.2 Termination of this Agreement shall not affect any rights or obligations accrued prior to the termination date.

6. Miscellaneous

6.1 This Agreement constitutes the entire understanding between the Parties and supersedes all prior agreements, whether written or oral, regarding the subject matter herein.

6.2 This Agreement may only be amended in writing, signed by both Parties.

6.3 This Agreement shall be governed by and construed in accordance with the laws of the state of Georgia.
